Council President Vath reported on the following:

The Board of Health meeting was cancelled for January 26, a special meeting was held on February 9.

The Board of Health looked at amending the ordinance regarding fees charged for vendors at the Marketplace and it was determined that \$10.00 per vendor would be an appropriate fee, the ordinance amendment to be introduced at the March Board of Health meeting, copy to be forwarded to Clerk's office.

The Board of Health 2011 budget was discussed, discussions to continue at March meeting. 2011 preliminary Borough Budget was discussed; however, the final budget could not be completed until State Aid numbers are released.

Councilman Fox reported:

Mr. Becker, Public Works Superintendent asked that the utility problems on Kakeout Road be inspected and addressed prior to the bid preparation. Mr. Lampmann noted that due to traffic concerns the work on Kakeout Road would actually begin in late spring or early summer.

Councilman Regis reported:

A firefighter needed to be transported to the hospital today because of assisting with a heavy lift request from the first aid squad.

Mr. Regis also noted that there are two (2) new fire department members at the Morris County Fire Academy, two (2) new fire department members at the Passaic County Fire Academy and (3) three new members of the first aid squad at the Bergen County EMS training center.

Councilman Verdonik reported:

The museum is in the process of boxing up items, exploring the possibility of only moving the items to one side of the museum during renovations.

The submission of a non-construction grant for Phase II rehabilitation of the museum will be submitted to Morris County on February 24, 2011.

There was a major water main break on Route 23; there are still two customers without water, a joint effort with Morris County to provide a portable water unit is being pursued. Repairs to the water main have not occurred yet.

Councilman Meier reported:

The electric crews have been tree trimming due to the weather conditions.

The Electric utility is also looking into rewiring upgrades, automated meter readings and GIS. Additionally, the utility is looking into the installation of capacitor banks on main feeders due to electric consumption over the past summer.

A garbage truck hit an electric pole in Bloomingdale, pole was stabilized the company will be billed for costs associated.

Installation of floodlights at Star Lake Camp, updated bill to be issued to include costs associated with installation and power usage.
