RESOLUTION AWARDING A CONTRACT FOR A 50 FOOT SHEAVE HEIGHT HYDRAULIC DIGGER DERRIC TO DUECO, INC.

WHEREAS, two bids were received for a 50 Foot Sheave Height Hydraulic Digger Derrick on July 30, 2014; and

WHEREAS, the apparent low bid by Altec Industries, Inc. took exception to several of the technical specifications, most notably the performance ranges including weight capacity of the equipment; and

WHEREAS, the Borough Administrator and Borough Attorney have reviewed the bid submitted by Altec Industries, Inc. and have advised the Council that, in their opinion, accepting a bid with these exceptions would adversely affect competitive bidding by placing the bidder in a position of advantage over other bidders or by otherwise undermining the necessary common standard of competition and have recommended that this bid be rejected as non-compliant with the bid specifications; and

WHEREAS, the second bid was received from Dueco, Inc. in the amount of \$219,171.00 and is in substantial compliance with the bid specifications.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Butler, in the County of Morris and State of New Jersey, that the bid for a 50 Foot Sheave Height Hydraulic Digger Derrick by Altec Industries, Inc. is hereby rejected as non-compliant with the bid specifications and the bid submitted by Dueco, Inc. in the amount of \$219,171.00 is hereby accepted and the contract is awarded to Dueco, Inc.
