Currently, he is experiencing difficulty in renting the minimart portion of his recently built gas station; he feels that it would be easier with additional parking spots. The current configuration does not allow for enough parking spaces for the minimart, he wants to either purchase or lease the property to add additional parking spots by shifting the fence back by approximately five feet. Discussion ensued and it was determined that the title needs to be researched, to determine who owns the property. The Mayor and Council would like to inspect the property and have the Planning Board review the proposal as the site plans would need to be amended. If this is, Municipal property the Borough has various options on how to proceed.
