Regarding the air conditioning for the Butler Museum, the \$40,000 will be for the entire unit, which includes a backup heat source. Mr. Lampmann explained that while the street sweeper would be overhauled, the motor would remain as it is in perfect working order. Councilman Travers asked if federal grant funding could be obtained to offset some of the costs of the purchase of the new fire truck, Mr. Lampmann explained that most of the federal grants usually go to a purchase that will benefit several communities.
