**Discussion** –Attorney Thomas Vigneault came forward on behalf of KPT Health & Wellness requesting permission to apply for a conditional license to sell marijuana. The council agreed to provide the required letter on Borough letterhead stating the applicant meets the requirements of the Borough ordinance. KPT has retained legal counsel from a firm experienced with cannabis sales and once they receive approval from the state, they will move forward. Council inquired about potential locations and reminded them to consider parking availability. Mr. Lampmann informed them that while there is no cap on the number of licenses, the number will be restricted based on the distance and location requirements in the Borough ordinance.

**Discussion** – Bill Budesheim proposed amendments to several Zoning and Land Use Ordinances. Most are updates and housekeeping issues. Other topics addressed were:

- Adjusting initial escrow deposits for the billable hours for engineer review
- Zoning code change to property located on Rt 23 from Residential to Highway Commercial
- Using a condensed version of our Zoning & Planning Board Variance Applications
- Whether we restrict messages/ads on privately owned digital signs and billboards
- Possible use of an "Overlay Zone" to encourage development on Main Street
- Proposed use of "Grannie Pods" or "Tiny Houses" on private property
- Requiring applicants to provide digital copies of plans rather than paper copies in order to cut down on storage needs and provide easier access for OPRA requests, etc.

Borough Attorney, Robert Oostdyk, noted that a Master Plan Review would need to be done to modify the majority of these issues.

#### Discussion - Alternate Route Police hiring

Mr. Lampmann explained that a recent change in legislation helps civil service towns like Butler hire police officers through the Alternate Route. This program has always existed but previously only for non-civil service towns. It allows the hiring of an officer who has already successfully completed the academy. This will benefit the town financially as the cost of the academy is approximately \$6,000-\$7,000 plus their salary. Additionally, it will allow us to have an officer on the job immediately rather than starting the academy in January and on the job next summer. The need for this is due to the retirement announcement of Chief Ciro Chimento. He will be retiring at the end of this year.

#### **OPEN PUBLIC DISCUSSION**

Mayor Martinez opened the meeting to the public at this time.

John Ahmuty, Vice President of Tri-Boro Little League came forward requesting a donation from the Borough for a permanent shed at Walter T. Bergen Softball Field to house all equipment at the field. He has already approached Bloomingdale for new bleachers, a sunshade, windscreen and netting. He pointed out that half of their roster is comprised of Butler residents. The Council advised Mr. Ahmuty to proceed through the Butler Recreation Department as they have money allocated in their budget to assist these programs. The Borough itself cannot give the money directly because every activity would then request money and we could not pick and choose who to give it to. Mr. Lampmann explained that another avenue to explore would be obtaining a mini-grant through our Clean Communities Program by holding a clean-up project. They could raise \$250-\$500 with all of the supplies being provided by the Borough.

Mayor Martinez told the Council that the VFW requested exemption from paying their water, sewer and electric utility bills like they do in Boonton. Council agreed that they cannot grant this because then all non-profits, Knights of Columbus, Churches, etc. would then have to be granted the same exemption.

Mayor Martinez wants to re-address the creation of a co-op in town. He would like us to explore the option of being a "secondary agency" for a co-op, from which we would receive benefits. Mr. Lampmann asked for clarification if we would be a "Secondary Agent" or a "Member" and what our liability would be. Mr. Lampmann and Council all agreed that a lot more information is needed as it seems odd that a borough would be eligible to receive money for doing nothing. Mayor Martinez is going to research this and report at a later time.
