## BOROUGH OF BUTLER COUNTY OF MORRIS Ordinance 2024-19

AN ORDINANCE OF THE BOROUGH OF BUTLER PROVIDING FOR THE APPROPRIATION OF \$52,500 FOR THE ACQUISITION OF COMPUTER EQUIPMENT FROM THE GENERAL CAPITAL - CAPITAL IMPROVEMENT FUND, WATER CAPITAL - CAPITAL IMPROVEMENT FUND AND ELECTRIC CAPITAL - CAPITAL IMPROVEMENT FUND.

BE IT ORDAINED, by the Mayor and Council of the Borough of Butler, County of Morris and the State of New Jersey as follows:

**SECTION 1.** The funding for the acquisition of computer equipment is hereby authorized with a cost not to exceed \$52,500, which sum is hereby appropriated for this purpose

**SECTION 2.** The total amount of \$52,500 for said improvements is hereby appropriated from the following funds:

General Capital - Capital Improvement Fund - \$22,000 Water Capital - Capital Improvement Fund - \$8,500 Electric Capital - Capital Improvement Fund \$22,000

SECTION 3. This ordinance shall take effect after publication and passage as provided by law.
